**Mr. Wayne Cowan**, Owner, Strategic Risk Solutions Ltd.

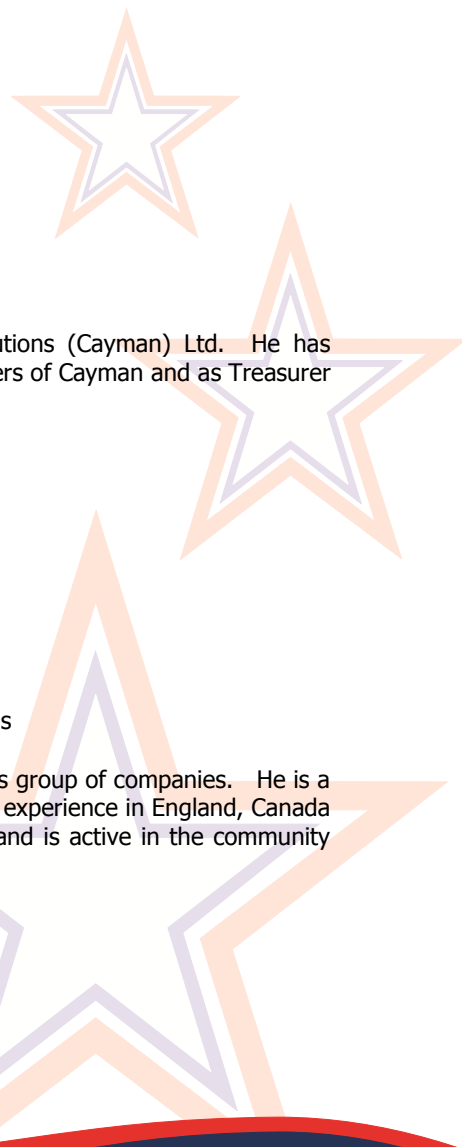
