Cayman Turtle Farm – CEO Wil Pineau, CCE

- The Board held a meeting on 18th March
 - Main highlights:
 - Income statement year to date vs. prior year (as of January 2015)
 - Revenue is up by 6%
 - Food and beverage is up by 15%
 - Retail is up by 64%
 - Tours is up by 19%
 - Gross profit is up by 8%
 - Expenses are better by 7%
 - Net profit/(loss) is better than previous year to date by 6% - Actual YTD (\$5,086,064) vs. (\$5,425,887)
 - Net profit/(loss) for YTD vs. Budget is 10% better
 - One of the company's loans will be repaid in May of this year.
 - Copies of the audited financial statements had been received
 - Other agenda items included:
 - Review of the CTF Board feedback on the proposed Public Authorities Law has been submitted
 - Rental Cabana has been added for tourist rentals

CONFERENCES AND MEETINGS

COSME update: Diana Henrickson-Fleming and Samuel Kruiner visited Grand Cayman on 25th March. The main focus of the visit was for the Project Management Unit (PMU) to share information about the Direct Assistance Grant Scheme. The Final report of the Grant Scheme and its supporting documents are being reviewed by the European Union and once endorsed the relevant documents will be circulated amongst all OCTs. The visit included:

1. A meeting with the focal points (Department of Commerce and Investment, Chamber of Commerce and Small Business Association) to present,
 - a. The work plan PE1 and status of affair of the implementation. (The scheduled dates for the next Stakeholder and SC meeting are scheduled for the first week of June 2015);
 - b. A synopsis of the Direct Assistance Grant Scheme (DAGS);
2. A General Information session took place at the Chamber's conference room with about 30 persons attending to present the "DAGS at a glance" to a wider BSO/SME population;
3. Train the Trainer workshop on the Grant Application process and the Guidelines for Applicants (Selected trainers (besides focal point members) should be preferable representative of SME membership based BSOs or SME training institutions)

The PMU received the Chamber's assistance to further define the target group and organise and invite selected stakeholders for both the General Information session as Train the trainer workshop(s).

DCI Small Business Expo: The Chamber has reserved a booth at this event and is sponsoring the reception.
