INTRODUCTION:

For those of you who may not know me, my name is Paul Pearson, and Cayman has been my home for over 16 years. I am the Managing Director and co-owner of Davenport Development, the developers for San Sebastian, Crystal Cove, Valencia Heights, Lantern Point and, now under construction, VELA on South Sound. Although I am originally from Ireland, I have lived in a number of countries developing my career in management, including hospitality and construction. I'm passionate about early education and believe that investing in our youth is essential for our future. I also believe that every business has a social responsibility to contribute in a meaningful way to enhance the community in which we conduct business. It is a symbiotic relationship – each relying on the other for success. Cayman has certainly been good to me

and that's why I made the decision several years ago to become involved with the Chamber. **I believe** It is important to make a contribution to keeping the good ship Cayman on a steady course.

The Islands, as we all know, have changed dramatically along with our expectations over the past 16 years. The pace of our Islands and the business community has **quicken**, and we now take many things for granted. As we all know, business never rests. **Innovation, adaptability** and new product development have kept Cayman attractive, not only to our local people, but international investors and visitors. It is time for us to **evaluate** our competitive position and to determine whether our current course is sustainable or if it needs adjustment.

Your involvement and interaction as members of the chamber will be essential in this process. The annual State of Business membership survey will be released in February, and I urge you **to respond** in order to have your voice heard. The results will enable

the Council to evaluate the current economic climate and **identify** **your** top areas of concern and opportunity. The survey results will provide the Council with useful information for the Strategic Planning session in late February and the development of a Plan of Action for the year and a three-year plan for the future.

Workforce Development

The private sector needs more qualified and motivated workers.

The protectionist/nationalist agenda of **limiting** work permits based on the belief that this will address unemployment among Caymanians **is ill-advised** and will only cause employers to downsize their businesses, **outsource positions** altogether or reduce their local operations. We need a national dialogue with honest and frank discussions on this topic. The Chamber is **willing** to engage its membership and the elected Government to develop sensible strategies that will provide the private sector with access to the skilled local and international labour that is required to **sustain and grow** businesses and the economy.

With Education

No building can stand without a firm foundation. This also applies to our workforce and the **preparedness** of the hundreds of high school students who graduate each year. Many young Caymanians attempt to enter the world of work but are ill-prepared for the current workplace. Education reform at all levels is **required** to bridge the gaps among the expectations of employers, the curricula in the classroom and the job prospects that are available in the marketplace. This will also require an open and frank dialogue with all stakeholders so that we can all direct our limited resources to the most effective use.

Economic Growth

Economic growth matters. Without a **thriving** private sector, Cayman has no future. Employment opportunities, infrastructure

development, education, and social and cultural initiatives all rely on its success. Economic growth **leads** to higher incomes, lower unemployment, **reduced** government borrowing, improved public services and infrastructure, funding for environmental initiatives to protect our natural resources and ultimately, increased investment – All leading to a virtuous cycle of economic growth and a higher standard of living for all people living on our islands. In politics, this message is often lost. The Chamber intends to **raise** the volume on this subject and to launch a public education campaign that will **provide** our nation with information about why economic growth matters, and to prompt the public to support growth. With Membership engagement :

Involvement is the key to any organisation's success. The Chamber needs more hands on deck to address the issues that matter in the areas of education, economic growth, business promotion, public policy, jobs creation and workforce development.
